SIR,— I have the honour to submit you herewith a report upon samples purchased throughout Canada in June and July last, as Ground Coffee. The following is a summary statement of the results of their examination:—

Of 26 samples found adulterated, 15 contained chicory only, and in amount not exceeding 10 per cent. These samples I have thought it right to indicate as *technically adulterated*, since it is fair to assume that no intention to defraud the purchaser exists. An article offered as coffee, should undoubtedly be nothing else than coffee, but so many consumers prefer a small addition of chicory that dealers frequently add an ounce or so to the pound in order to meet a known expectation of the customer.

This does not hold where the amount of chicory present is excessive (I have drawn the limit at 10 per cent), nor does it hold where roasted grain, or other starchy material is added.

The following table shows the results of coffee inspection in Canada since the year 1888:—

Samples not accounted for in the columns headed 'Adulterated' and 'Genuine' were classified as 'doubtful,' or 'sold as compound.' It is very satisfactory to observe that a great improvement in the character of this article is evidenced.

At first sight it might seem practicable, and perhaps even desirable, to fix a limit for chicory, beyond which the addition of chicory to coffee, without declaration of the fact, should be regarded as actual adulteration. Such suggestion will not bear criticism, and the only tenable procedure would seem to be the distinct declaration that chicory is present, whenever it has been added in any quantity however small.

I beg to recommend the publication of this report as Bulletin No. 216.
